Nondiscrimination

The School District does not discriminate on the basis of prohibited factors in employment and educational programs/activities. The School District affirmatively strives to provide equal opportunity for all as required by:

Title VI of the Civil Rights Act of 1964 - prohibits discrimination on the basis of race, color, religion, or national origin. Title VII of the Civil Rights Act of 1964 as amended - prohibits discrimination in employment on the basis of race, color, religion, gender, or national origin. Title IX of the Education Amendments of 1972 - prohibits discrimination on the basis of gender. Age Discrimination in Employment Act of 1967 (ADEA) as amended - prohibits discrimination on the basis of age with respect to individuals who are at least 40. The Equal Pay Act of 1963 as amended prohibits gender discrimination in payment of wages to women and men performing substantially equal work in the same establishment. Section 504 of the Rehabilitation Act of 1973 - prohibits discrimination against the disabled. Americans with Disabilities Act of 1990 (ADA) - prohibits discrimination against individuals with disabilities in employment, public service, public accommodations and telecommunications. The Family and Medical Leave Act of 1993 (FMLA) - requires covered employers to provide up to 12 weeks of unpaid, job-protected leave to "eligible" employees for certain family and medical reasons. The Pregnancy Discrimination Act of 1978 - prohibits discrimination in employment on the basis of pregnancy, childbirth, or related medical conditions. The Uniformed Services Employment and Reemployment Rights Act (USERRA) - provides job protections and reemployment rights to military reservists and National Guard members called to active duty. The Nebraska Fair Employment Practice Act (FEPA) - prohibits employment discrimination on the basis of race, color, national origin, religion, sex (including pregnancy), disability, marital status, and retaliation. Nebraska Age Discrimination in Employment Act (Age Act) - prohibits employment discrimination on the basis of age for those individuals who are over 40 years of age. The Equal Pay Act of Nebraska - prohibits discriminatory wage practices based on sex. The Nebraska Equal Opportunity in Education Act - prohibits discrimination on the basis of sex (including pregnancy) by any educational institution. Veterans Preference Law (Neb. Rev. Stat §§ 48-225 to 48-231) - stipulates categorical preferences for employment for military veterans and for the spouses of disabled veterans. Additional School Board policies prohibit harassment and/or discrimination against students, employees, or patrons on the basis of sex, race, color, ethnic or national origin, religion, marital status, disability, age, pregnancy, and any other legally prohibited basis. Retaliation for engaging in a protected activity is also prohibited. Any person who believes she or he has been discriminated against, denied a benefit, or excluded from participation in any district education program or activity may file a complaint using the district's complaint procedures.

Inquiries regarding compliance with any of the laws referred to in this policy may be directed to the superintendent or to the district's Title IX and/or Section 504/ADA Coordinator.

Jr-Sr High School Pick Up/Drop Off

All students should be dropped off in the west parking lot and enter through the front doors. Be considerate of our buses as this is also the bus drop-off area.

Picking up students <u>during the school day</u> should always be done in the west parking lot as they exit from the office. Students may meet you in the parking lot.

At the end of the school day <u>all students</u> who are being picked up will exit the south doors to the south parking lot.

1. Pull all the way up in the pickup lane so cars don't get stacked up and 2. If vehicles do get backed up, pull into a parking space so vehicles are not stopped on Lincoln Street as we have had complaints about traffic being stopped on the street. There is plenty of room in the parking lot for all the vehicles. After practices parents should park in the west lot not on the drive. This lot has traffic and the front drive is a bus lane

and an emergency area which should not be used.

The USDA is allowing School Food Associations to operate in the same manner as 2020-21. All



schools will provide **FREE** meals to all students grades K-12 in 2021-22. Please remember that it is only the first meal

that is free. Any milk, a la carte, seconds or second meals are charged at the regular rate. These prices remain the same as 2020-21 and are found on the schools' website under "School" and "Food Service". We also ask that if you think you qualify for meal benefits to fill out the application in the same area of the website and submit it to your school's principal. This information can be used for additional benefits for the schools, students and families. The schools will prepare all meals using the Federal meal patterns which emphasize a renewed focus on providing nutritious meals to best support students' learning.

The sports physical must take place after May 1 2021 to qualify them for the 2021-2022 school year. Return a copy of the physical to the high school office when completed. The specific line we are looking for is "the athlete is cleared without restrictions to participate in athletics."

Parental Consent Forms must also be turned into the main office before any athlete may participate in their activity. Parental Consent Forms can be found on the first page of the Fort Calhoun Activities Handbook. Coaches from each activity will hand all athletes the handbook before the first day of practice. Signed forms can be returned to your coach or main office.
