On August 11th we will welcome back over 800 students to Fort Calhoun Community Schools. Regarding school meals, school districts have been notified that the USDA does not have the authority to extend waivers that allow no-cost meals to all students. To alleviate some of the financial hardship this may cause, a waiver was put in place that allows schools to use the benefits that were on file from the 2019-20 school year to grant a 30-day carryover of the benefits from that time. This will allow families extra time to file meal applications for 2022-23.

Enjoy the rest of summer break as we get geared up for the start of school. We look forward to a positive and successful year with our students, staff, and community.

Thank you to all the staff who have worked so hard this summer to prepare for the new school year.

The Nebraska Fair Employment Practice Act (FEPA) -prohibits employment discrimination on the basis of race, color, national origin, religion, sex (including pregnancy), disability, marital status, and retaliation. Nebraska Age Discrimination in Employment Act (Age Act) -prohibits employment discrimination on the basis of age for those individuals who are over 40 years of age. The Equal Pay Act of Nebraska-prohibits discriminatory wage practices based on sex. The Nebraska Equal Opportunity in Education Act-prohibits discrimination on the basis of sex (including pregnancy) by any educational institution. Veterans Preference Law (NEB.REV.STATS§ 48-225 to 48-231) -stipulates categorical preferences for employment for military veterans and for the spouses of disabled veterans. Jr-Sr High School Pick Up/Drop Off

All students should be dropped off in the west parking lot and enter through the front doors. Be considerate of our buses as this is also the bus drop-off area.

Picking up students <u>during the school day</u> should always be done in the west parking lot as they exit from the office. Students may meet you in the parking lot.

At the end of the school day <u>all students</u> who are being picked up will **exit the south doors to the south parking lot**. 1. Pull all the way up in the pickup lane so cars don't get stacked up and 2. If vehicles do get backed up, pull into a parking space so vehicles are not stopped on Lincoln Street as we have had complaints about traffic being stopped on the street. There is plenty of room in the parking lot for all the vehicles. After practices parents should park in the west lot not on the drive. This lot has traffic and the front drive is a bus lane and an emergency area which should not be used.

If you have already received notification of 2022-23 benefits granted through direct certification, your student(s) will begin receiving them on the first day of school. If you have not, we urge you to complete the necessary paperwork immediately if you believe you qualify. Forms can be found on the school website under "Food Service". Students will have to pay for meals until such time this is received. School board policy states "The district's policy on charged meals is: "If a student has no funds available to pay for a meal, the student will be permitted to charge up to five meals. OPTION ENROLLMENT 2023-24

The Option Enrollment application period for the 2023-24 school year is open September 1, 2022 through March 15, 2023. Forms are available on our website or at the school offices. The School Board sets class size and program parameters in February/March According to State law, and all applicants must be notified one way or the other by April 1st. Applicants are taken on a first-come. first-serve basis.

Those two emotions, with many others, keep me motivated to be the best. As you know, to be the best, you must possess a mindset of greatness and put in the hard work. That effort mandates not just hard work, it mandates MORE! We are coming upon a crucial year. This upcoming school year is going to bring more hidden challenges and priorities than we even know. I understand you need to feel like you are standing up for your child. However, the school needs to stand up for ALL students, not just one. These are just a few examples of showing support to our teachers, staff, and school. We must put 100% confidence in the school. The challenges we have overcome have made us even stronger. Let's not let the challenges that are coming diminish the progress we have accomplished. I hope this letter positively frames the crisis the educational world is in without being overbearing. Sports physicals need to be completed and turned into the main office for all incoming 7-12athletes before athletes may participate and compete. Athletes will not be able to participate in any activities starting August 8, 2022, without a sports physical. The sports physical must take place after May 1, 2022, to gualify them for the 2022–2023 school year. Return a copy of the physical to the high school office when completed. The specific line we are looking for is "the athlete is cleared without restrictions to participate in athletics."

Parental Consent Forms must also be turned into the main office before any athlete may participate in their activity. Parental Consent Forms can be found on the first page of the Fort Calhoun Activities Handbook. Coaches from each activity will hand all athletes the handbook before the first day of practice. Signed forms can be returned to your coach or main office.

The mission of Teammates is to positively impact the world by inspiring youth to reach their full potential through mentoring. But how can we ensure we are living up to this important mission?

While a Teammates mentor is not meant to be a tutor, to fix absenteeism, or to correct behavior, we have found that the mentoring relationship has an indirect effect on the grades, attendance, and behavior of students. In our chapter's 2021 annual survey we found that 87% of mentees state that having a mentor makes them excited to go to school. But don't take my <u>PEAMMATES</u> word for it; listen to thew words of one recent mentee (I got permission from this mentee to use this. "Without my mentor I don't think I would have made it through without any trouble and may not have even passed my classes. My mentor really helped me put my life on track when I felt like giving up."

By simply showing up week after week, mentors build on a sense of hope in their mentee. Our 2021 annual survey also found that 91% of mentees reported higher levels of hope because of their mentor. This hopefulness manifests itself in greater confidence and positive feelings about the future. One student put it this way "A mentor can make you feel hopeful when all else seems to go wrong." Another student noted, "My Teammate teaches me that there is hope in my future and he believes in me."

I am proud of our chapter and the difference that we have made in the lives of some of the youth in our community and I hope that we can keep our chapter going strong for a very long time. But to do this, we need mentors. Please consider becoming a mentor. It only takes 30 minutes per week to make an impact.
