The first day of school is Thursday, August 11th and it will be an 11:30 am dismissal for the Junior-Senior High School.

Your class schedule will be available to you on your PowerSchool account beginning August 1st. If your schedule has any class periods without a scheduled class, you need to schedule a time with Mrs. Hernandez (Grade 9, 10, 11 & 12 Students) or Mrs. Adams (Grades 7 & 8) during the schedule change dates of August 3rd through August 5th. You can schedule an appointment by contacting the HS office. Just a reminder students, you have 7 periods in your day and your lunch is along with your 5th period class.

School districts have been notified that the USDA does not have the authority to extend waivers that allow no-cost meals to all students. In light of this, Fort Calhoun students will return to paying for school meals. To alleviate some of the financial hardship this may cause to any family that qualifies for free/reduced meals, a waiver was put in place that allows schools to use the benefits that were on file from the 2019–20 school year to grant a 30 day carryover of the benefits from that time. Student drop-off will be the same as last year. All students must enter the building through the main entrance. Students that are being picked up after school will exit the south doors and be picked up in the south parking lot. Parents are encouraged to park in a parking spot in the south parking lot and have your student walk out to you. This will alleviate congestion in a pick-up line. Students who drive or ride the bus will exit at the main entrance.
