


SCHOOL IMPROVEMENT & GOALS

All students will improve math scores across the curriculum.

The focus of the School Improvement program for the 2013-14 school year was reorganization and staff development. The 2013-14 school year was the second year of reorganization of our School Improvement efforts. Our Elementary Principal has been appointed to lead these efforts and the team. The process was also improved by the addition of Data Instructional Leaders being appointed at both buildings. These additional personnel positions were implemented to enhance the School Improvement process. These new positions, along with the new standards, have given our District a new and more focused approach to the School Improvement process.

THE FORT CALHOUN SCHOOL-COMMUNITY



The Fort Calhoun Community School District is located in the southern portion of Washington County, Nebraska, just north of Omaha. To the northwest of Fort Calhoun is the Blair community and school system. East of the Fort Calhoun School District is the Missouri River and to the south is the city of Omaha and the Omaha Public School District. The community of Fort Calhoun lies just outside the Omaha metropolitan area. The Fort Calhoun Community School District contains approximately 58 square miles with 56 square miles located in Washington County and two square miles in Douglas County. The assessed valuation of the District is \$ 339,625,338.

SCHOOL ACCREDITATION

The focus of modern accreditation is to help schools continually improve student performance and school conditions. All facilities and programs in the Fort Calhoun Community Schools meet Rule 10 accreditation standards as set by the Nebraska Department of Education. In addition, the Elementary School and Junior-Senior High School are members of the AdvancED Accreditation Systems for accreditation and school improvement. The Fort Calhoun Community Schools will be hosting a Quality Assurance Review during the 2014-2015 school year. Teams are actively preparing for the visit in April 2015 and developing a true improvement process that will be embedded in our District for years to come.





FINANCES

A levy override impacted fiscal years from 2006-07 through 2009-2010 with an amount of \$.20 voted allowable above the statutory levy limit. The purpose of the levy override was to address financial obligations of the district, debt retirement, and to build cash reserve. All were achieved. During the 2013-14 school year, the District had no short-term borrowing, and overall budget operations ended the fiscal year with a positive balance.

BUILDING/SINKING FUND – Budget - \$927,156. Funds are available to pay for major costs of improvements to the District's facilities. Building Fund monies can be accumulated from year to year and may be used to supplement furnishings in the new facility. Other building improvements, maintenance and repairs may be paid from the General Fund category "Operation and Maintenance of Plant."

LEARNING CLIMATE

Fort Calhoun Community School District is accredited through the NCA AdvancED and the Nebraska Department of Education. Pioneers For Education (PFE), the Fort Calhoun Athletic Booster Club, Band Boosters and Post-Prom Committee, the Pioneer Fund Foundation, local service organizations, school staff, parents and patrons of the District work together in support of student efforts. Graduating seniors participate in exit interviews, and complete surveys related to their school experiences. Parent-Teacher Conferences provide opportunities for parents and instructors to discuss students, their academic progress, and educational plans face to face. Attendance during the 2013-14 school year: Elementary - Fall = 98%; Spring = 96%; **Secondary** - Fall = 76%; Spring = 52%. Interactive school/student/teacher information is also available through PowerSchool™. Increased use of the resources available through Powerschool™ and District website contacts have allowed parents to continually monitor their students' progress.



TRANSPORTATION

The district transported an average of over 200 students each day. During the 2013-14 school year, four (4) daily rural routes covered 66,383 miles with another 29,509 miles for activity transportation. Special education transportation services are provided to qualifying students and are included in these numbers.



FOOD SERVICE

The Fort Calhoun Community Schools food service program is self-supporting and participates in the Federal reimbursement program for commodities and meal reimbursements. We continue to comply with the necessary procedures to receive additional reimbursement under the Healthy Hunger-Free Kids Act program which incorporates more whole grains and fruits/vegetables into the daily offerings. The total program follows dietary guidelines mandated by the USDA to provide daily, balanced meals at a reasonable cost. During the 2013-14 school year: Average daily breakfast participation was - Elementary, 20.06 students; Secondary – not offered. Average daily lunch participation was – Elementary, 159.16 students and 5.58 adults; Secondary, 235.47 students and 8.47 adults. Figures reported for students reflect reimbursable, "Type A" student meals. "A la carte" food items and milk are available for purchase. Meals are also available to qualifying students free or at reduced prices.

SPECIAL EDUCATION

The Fort Calhoun Community Schools provide special education services to qualifying students from birth through age 21 as required by Nebraska Department of Education (NDE) Rule 51. Students receive services provided on-site by school staff relating to one or more of the disability categories identified by NDE. A pre-school program staffed and operated by the Fort Calhoun School District integrates instruction and services for special needs students during which times they interact with age-appropriate "peer" role models. School-age services are provided at Fort Calhoun Elementary School, Fort Calhoun Junior-Senior High School and the Pioneer Learning Center (PLC). The PLC also provides qualifying students with appropriate programming while allowing them to attend school within the City of Fort Calhoun. Students from neighboring school districts are still contracted to attend the PLC for services. The building, acquired through the City of Fort Calhoun from Memorial Community Hospital, has been updated to provide students a reallife atmosphere in which to prepare for real-world opportunities. Fort Calhoun Schools serve 16.72% of the student body through these programs. The state average is 15.74%.

Fewer than 10 students were reported in the grade or standard.
 In 2014 students in grades 8 and 11 experienced website technology issues with the online test. Valid results are not available for all districts or for the state NeSA-Writing in grades 8 and 11.



TECHNOLOGY

The Fort Calhoun Community Schools continue to provide students with opportunities to learn and apply relevant technology skills. Students are provided experiences to prepare them to live in an "information age." The school's computer network, with hard-wired and wireless access available, is used to deliver information to students and to help students become creators of information, not just consumers. The School Board met their goal of establishing a "one to one" initiative where all staff and students grades 9-12 have an iPad thereby placing in every teacher and students' hands a technological tool to enhance and facilitate their capacity and capability to learn. Computer lab settings and mobile computer labs are available at each building to allow cross-curriculum technology applications by students and staff members. Apple, Inc. again designated Fort Calhoun as an Apple Distinguished Program for the years 2013-2015. The District continues its use of "PowerSchool," a student information system that allows students and parents access to a wide array of information. This service is linked to the school website found at www.fortcalhounschools.org. The District also is connected to the Nebraska Department of Education's data tracking system, Nebraska Student and Staff Reporting System (NSSRS), developed to consolidate data gathering from all Nebraska schools which is used to map achievement, direct student growth and follow students after graduation. AlertNow®, an automated messaging system is still being used for emergency notification. As of the end of the year, the Board of Education conducts its meetings "paperless" through shared electronic media sponsored by NASB-NETS. The e-meetings website is an interactive system where information, documents and commentary are immediately available and can be archived for future reference. In the works for the 2014-15 school year is a Robotics class through our Career Education program.
